Regular Meeting Minutes  
October 17, 2018

The meeting was called to order at 7:00 p.m. by Supervisor, Jacque Phillippe. Board members present were Pitts, Pugsley, DeLeo, and Melvin.

Motion by Pitts supported by Melvin to accept the minutes of the September 19, 2018 as read. Motion Carried.

Police Report-- There were (24) calls in the township last month.

Planning Commission Report-- Next PC committee meeting will be December 5, 2018. Based on the submitted Findings of Fact (enclosed) the Planning Commission recommended that the Board approve a MM Grower Permit and Site Plan for Grow Arlington LLC. Motion by Pitts supported by Melvin that the Board adopt the Findings of Fact of the Planning Commission and approve the application for the Special Use Permit and Site Plan subject to the condition that the applicant must comply with all requirements imposed by the Van Buren County Drain Commissioner regarding retention ponds and drainage prior to commencing operations. Motion Carried. An amendment to the zoning ordinance concerning trucking companies located in the AG-RES. District was tabled until a later date. A Special PC meeting may be scheduled for December 10, 2018 to review additional zoning issues and permit requests.

Ordinance Officer Report-- John reported the status of issues concerning Mrs. Puckett and Mr. Mims.

Clerk report-- Pugsley noted to the Board that a FOIA request from the state Republican Party had been received pertaining to the upcoming Mid-Term election.

Supervisor Report-- It looks like our Transfer Station will be used for Tire recycling in 2019. The Scott Lake Association has expressed an interest in doing waste recycling around the lake.

Treasurer Report-- Phil requested that he be allowed to pay the election inspectors after the election concludes on Election Day. Motion by DeLeo supported by Pugsley to pay the inspectors. All members voted yes. Phil noted that he had not received any billing notification from the party cleaning the Hall. He will look into it Motion by DeLeo supported by Pugsley to pay the bills. All members voted yes.
